The bond herein shall be in the sum of \$5,000, or cash may be deposited in lieu of such surety bond.

Please attach a copy of the liability insurance policy issued by an insurance company in the amount of \$100,000 per person, \$300,000 per accident as to personal injury, and \$50,000 in property damage.

Application for a permit must be filed at least 24 hours prior to moving.
